



**Mandatory Short Term Disability (STD) Insurance**

Short Term Disability insurance pays a weekly benefit in the event you cannot work because of a covered illness or injury. An STD benefit replaces a portion of your weekly income, providing funds directly to you to help pay your bills and living expenses. Standard Insurance Company (The Standard) has developed this document to provide you with information about the optional coverage you may select through Oregon Educators Benefit Board.

**Eligibility Requirements**

**Employee**

To be eligible for STD insurance coverage:

- You must be a regular employee of an employer participating in the Oregon Educators Benefit Board (OEBB) STD insurance group policy
- You must meet other eligibility requirements included in the member definition of the group policy and as required and determined by OEBB
- Your employer must have elected to make STD coverage available to employees in your classification
- You must not be a full-time member of the armed forces of any country

**Benefit Amount and Duration**

**Benefit Percentage**

Your weekly STD benefit is 60 percent of the first \$2,500 of your weekly insured predisability earnings, reduced by deductible income

**Benefit Waiting Period**

7 days

**Plan Minimum Weekly Benefit**

\$15

**Maximum Benefit Period**

60 days. However, STD Benefits will end on the date Long Term Disability benefits become payable to you under a group plan provided by your employer, even if that occurs before the 60 days.

**Becoming Insured**

Coverage under STD Plan 37 is mandatory/employee paid. If your employer elects STD coverage under Plan 37 for employees in your classification, all eligible employees in your classification must become covered under the group policy and make the required premium contributions.

Your coverage will be effective on the date you become an eligible employee and complete any eligibility waiting period, provided you meet the active work requirement on that date. This means that if you are not actively at work on the day before the scheduled effective date of insurance, your insurance will not become effective until the day after you complete one full day of active work as an eligible employee.

**Understanding Your Plan Design**

<b>Definition of Disability</b>	<p>You will be considered disabled if, as a result of physical disease, injury, pregnancy or mental disorder:</p> <ul style="list-style-type: none"> <li>• You are unable to perform with reasonable continuity the material duties of your own occupation, and</li> <li>• You suffer a loss of at least 15 percent in your predisability earnings when working in your own occupation</li> </ul> <p>You are not disabled merely because your right to perform your own occupation is restricted, including a restriction or loss of license.</p>
<b>Deductible Income</b>	<p>Deductible income is income you receive or are eligible to receive while STD benefits are payable. Deductible income includes, but is not limited to:</p> <ul style="list-style-type: none"> <li>• Sick pay, annual or personal leave pay, severance pay or other forms of salary continuation (including donated amounts)</li> <li>• Amounts under an unemployment compensation law</li> <li>• Amounts because of your disability under any other group insurance</li> <li>• Disability or retirement benefits under your employer’s retirement plan</li> <li>• Amounts under any state disability income benefit law or similar law</li> <li>• Earnings from work activity while you are disabled, plus the earnings you could receive if you worked as much as your disability allows</li> <li>• Earnings or compensation included in your predisability earnings which you receive or are eligible to receive while STD benefits are payable</li> <li>• Amounts due from or on behalf of a third party because of your disability, whether by judgment, settlement or other method</li> <li>• Any amount you receive by compromise, settlement or other method as a result of a claim for any of the above</li> </ul>

**Additional Features**

Please see your human resources representative for additional information about the features and benefits below.

<b>Rehabilitation Plan</b>	<p>If you are participating in an approved Rehabilitation Plan, The Standard may include payment of some of the expenses you incur in connection with the plan including but not limited to; training and education expenses, family (child and elder) care expenses, job related expenses and job search expenses.</p>
<b>Reasonable Accommodation Expense Benefit</b>	<p>If your employer makes an approved work-site modification that enables you to return to work while disabled, The Standard will reimburse your employer up to a pre-approved amount for some or all of the cost of the modification.</p>
<b>Return to Work Incentive</b>	<p>Rewards employees who return to work on a part-time basis by coordinating disability benefit payments with work earnings to provide 100% of predisability earnings.</p>

**Exclusions**

You are not covered for a disability caused or contributed to by any of the following:

- Your committing or attempting to commit an assault or felony, or your active participation in a violent disorder or riot
- An intentionally self-inflicted injury
- War or any act of war (declared or undeclared, and any substantial armed conflict between organized forces of a military nature)
- Disability arising out of or in the course of any employment for wage or profit

**Limitations**

STD benefits are not payable for any period when you are:

- Not under the ongoing care of a physician in the appropriate specialty as determined by The Standard
- Not participating in good faith in a plan, program or course of medical treatment or vocational training or education approved by The Standard, unless your disability prevents you from participating
- Confined for any reason in a penal or correctional institution
- Able to work and earn at least 15 percent of your predisability earnings in your own occupation, but you elect not to work
- Eligible to receive benefits for your disability under a workers' compensation law or similar law

**When Benefits End**

STD benefits end automatically on the earliest of:

- The date you are no longer disabled
- The date your maximum benefit period ends
- The date you die
- The date benefits become payable under any other disability insurance plan under which you become insured through employment during a period of temporary recovery
- The date you fail to provide proof of continued disability and entitlement to benefits
- The date long term disability benefits become payable to you under a long term disability plan

**When Insurance Ends**

Insurance ends automatically on the earliest of the following:

- The date the last period ends for which a premium was paid
- The date your employment terminates
- The date the group policy terminates
- The date you cease to meet the eligibility requirements (insurance may continue for limited periods under certain circumstances)
- The date your employer ceases to participate under the group policy

**Group Insurance Certificate**

If coverage becomes effective, and you become insured, you will receive a group insurance certificate containing a detailed description of the insurance coverage including the definitions, exclusions, limitations, reductions and terminating events. The controlling provisions will be in the group policy. Neither the information presented in this summary nor the certificate modifies the group policy or the insurance coverage in any way.

**Rates**

If you have questions regarding how to determine your earnings, please contact your human resources representative. Premiums for this coverage will be deducted directly from your paycheck.

To calculate your monthly payroll deduction, use the formula indicated below:

1. Enter your average monthly earnings, not to exceed \$2,500, on Line 1.                      Line 1: \_\_\_\_\_
2. Monthly premium rate is 0.00209.                      Line 2: 0.00209
3. Multiply Line 1 by the amount entered on Line 2.                      Line 3: \_\_\_\_\_

The amount shown on Line 3 is your estimated monthly payroll deduction.
