

## Frequently Asked Questions About Filing A Long Term Disability Claim

The following questions and answers will help you file a Long Term Disability (LTD) claim with Standard Insurance Company (The Standard) if you are an Orange County Board of County Commissioners or Orange County Comptroller's Office employee. The steps outlined below will enable you to access our efficient claims services quickly and easily.

### When Should I Report A Claim?

---

Report a claim as soon as you believe you will be absent from work beyond 180 calendar days. If you are uncertain about how long you will be absent or whether you should file a claim or not, we suggest that you file your claim. This offers you some peace of mind and allows for The Standard to begin its review and issue a timely payment if appropriate.

### How Do I File A Claim?

---

To file a claim by telephone, contact The Standard's Claim Intake Service Center at 844.870.8634.

To file a paper claim you will need to access the LTD claim form which can be found at [https://www.standard.com/eforms/3379\\_641718.pdf](https://www.standard.com/eforms/3379_641718.pdf) or contact Terri Gridley at [Terri.Gridley@standard.com](mailto:Terri.Gridley@standard.com) or 407.913.3458. You will need to complete pages 2 thru 8 and your physician pages 13 & 14 of the packet. The Employer Statement will automatically be filed by Orange County once the claim is received.

A typical application for disability benefits contains the following documents:

- Employee's Statement<sup>1</sup> (Page 2 thru 4)
- Employer's Statement<sup>2</sup> (Pages 10 & 11)
- Attending Physician's Statement (APS)<sup>3</sup> (Pages 13 & 14)
- Authorization to Obtain and Release Information (Page 6 & 8)

### When I Report My Claim, What Information Will I Need To Provide?

---

You will be asked to provide the following information — in addition to other questions about your absence:

- Employer name: **Orange County Board of County Commissioners or Orange County Comptroller's Office**
- Group Policy number: **641718**
- Name and Social Security number
- Last day you were at work
- Nature of claim/medical information
- Physician's contact information (**name, address, phone and fax number**)<sup>3</sup>

### What Are The Hours Of Operation For The Claim Intake Service Center?

---

If you choose to submit your claim by telephone, The Standard's Claim Intake Service Center representatives are available to assist you Monday through Friday, 8:00 a.m. through 8:00 p.m., Eastern Time.

## **Where Do I Send The Completed Forms?**

---

Completed Employee Statement (Page 2 thru 4) and Authorization to Obtain and release Information (Page 6 & 8) and Attending Physician's Statement (Pages 13 & 14) should be faxed directly to The Standard Office at 800.378.6053 or mailed to:

## **What Can I Expect After I Submit The Completed Forms?**

---

Once The Standard receives the required paperwork, which includes the Employee's Statement, Employer's Statement, Attending Physician's Statement and Authorization to Obtain and Release Information, your benefits analyst will contact you to discuss any additional information that may be necessary to complete the processing of your claim and to answer any of your questions.

## **If My Claim For Benefits Is Approved, How Long Will It Take To Receive My First Check?**

---

After the Benefit Waiting Period as outlined in your group policy is served, LTD benefit payments are paid in arrears on a monthly basis based on the date of disability and are mailed directly to your residence. LTD benefit payments that are payable for retroactive claims will be paid immediately following claim approval.

## **Who Is Responsible For Notifying Orange County Board of County Commissioners Of My Absence?**

---

It is your responsibility to follow the normal Orange County Board of County Commissioners absence reporting procedures by notifying your manager or supervisor of your absence and filing for FMLA if applicable.

<sup>1</sup> If you file online or by telephone, your submission serves as the Employee's Statement and we will instruct you on which other documents need to be completed.

<sup>2</sup> The Standard will contact your Employer to obtain the information necessary on the Employer's Statement.

<sup>3</sup> It is your responsibility to provide the Attending Physician Statement to your treating physician to complete and fax back to The Standard.
