

## GROUP BASIC LIFE AND ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE

Group Basic Life insurance from Standard Insurance Company helps provide financial protection by promising to pay a benefit in the event of an eligible member's covered death. Basic Accidental Death and Dismemberment (AD&D) insurance may provide an additional amount in the event of a covered death or dismemberment as a result of an accident.

The cost of this insurance is paid by your employer, Montgomery County.

Eligibility	
Definition of a Member	You are a member if you are a regular employee of Montgomery County and actively working at least 21 hours each week. You are not a member if you are a Public Health employee, a temporary or seasonal employee, a full-time member of the armed forces, a leased employee or an independent contractor.
Class Definition	Class 1 Union members, other than BCC-AFSCME and SEIU members Class 2 All other members
Eligibility Waiting Period	If you are already a member on the date the group policy is effective, you are eligible on the first day of the calendar month that follows the date you become a member. If you become a member after the group policy effective date, you are eligible on the first day of the calendar month that follows the date you become a member.

Benefits	
Basic Life Coverage Amount	Your Basic Life coverage amount is: Class 1 \$50,000 Class 2 \$60,000
Basic AD&D Coverage Amount	For a covered accidental loss of life, your Basic AD&D coverage amount is equal to your Basic Life coverage amount. For other covered losses, a percentage of this benefit will be payable.
Age Reductions	Your insurance will not be reduced because of your age.
