



PLAN 2 DEPENDENTS LIFE INSURANCE

Plan 2 Dependents Life insurance is underwritten by Standard Insurance Company (The Standard) and allows insured members to provide life insurance for their spouse and/or eligible children. This provides additional financial security for employees and their families. Children are covered from live birth through age 25.

To become eligible for coverage, employees must be:

- An active employee of any bank which is participating in the NBA Benefit Plans
- Regularly working at least 17.5 hours per week
- Serve the group policy’s eligibility waiting period determined by the participating Employer
- Enrolled for Plan 2 Group Life insurance
